




## General Fund Revenue and Expense History



### General Fund Revenues by Source




## General Fund Expenses by Category



### General Fund Fund Balance History




#### General Fund Solvency Ratio History




#### General Fund Days Net Cash History



# General Fund – Unspent Balance of Spending Authority




#### General Fund Fund Balance and Spending Authority


